

Pricing


ICANotes licenses are available for a recurring monthly fee. Prescribing clinicians, non-prescribing clinicians, and office staff have different price points. An annual license fee is also charged for each user.

Special pricing is available for groups in excess of 4 clinical users, for newly established practices, and for nonprofit organizations.

Unlimited training, support, and maintenance is included in the base monthly fee. There is no annual contract. Accounts may be canceled at any time with 15 days' notice.

Additional fees are charged for optional features: electronic signature software, e-prescribing, credit card processing, and billing services.
