A normal amount of physical activity was exhibited by Jenny today. Jenny today spoke of self defeating behavior. Jenny today spoke of issues associated with substance abuse. Jenny describes substance cravings. She admits she was tempted to use. Jenny denies use.

Suicidal ideas or intentions are not in evidence and not expressed. No suicidal plans are present.
