INTERVAL HISTORY:

Problem Pertinent ROS: Depressive symptoms are described today. Diana describes anhedonia. She has a poor appetite. Difficulty concentrating is reported. She states crying spells have become more frequent recently. Diana reports episodes of excessive worrying and a worsening of excessive fatigue symptoms. Hopeless feelings are described. There is an increase and worsening in her irritability symptoms. Diana describes feeling sad. She reports that her decreased libido has worsened. Brief, fleeting ideas of suicide are today reported by Diana. She reports difficulty with forming thoughts. Suicidal ideas are today acknowledged but she denies suicidal intentions or plans. Denial is convincing. Actual suicidal plans are denied. Diana today reports that suicidal ideas or impulses are decreasing in intensity and frequency. A firearm is not accessible to Diana.

BEHAVIOR:

Self-care skills are intact and unimpaired. Diana's domestic skills are intact. Her relationships with family and friends are normal. Medication has been taken regularly. Diana is performing normally at work. She has maintained sobriety. Her anger is well controlled. Impulsive behaviors are not currently being displayed. Diana's food and water intake is normal. A good night's sleep is reported.

ALLERGIES / ADR:

Adverse Drug Reactions and Allergies/Intolerances: Adverse Drug Reactions and Allergies/Intolerances were reviewed and no ADRs or Allergies/Intolerances were reported.

THERAPY CONTENT/CLINICAL SUMMARY:
